Project Location: The project is located within the Dobbyn Creek watershed, approximately 5 miles northeast of the town of Alderpoint, County of Humboldt, State of California; Assessor's Parcel Number 216-202-009; latitude 40.2356 N and longitude 123.5588 W at the point of diversion (POD).

Project Description: The project is limited to five (5) encroachments. One encroachment is for water diversion from an unnamed tributary to North Fork Dobbyn Creek. Water is diverted for domestic use and irrigation. Work includes removal of disused/abandoned diversion infrastructure, and the installation, use and maintenance of approved water diversion infrastructure. The four other proposed encroachments are to replace existing stream crossings. Work for these encroachments will include excavation, removal of fill and debris, replacement with new properly designed crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
