Project Title: Dazzi Pond Overflow Spillway and Water Diversion Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-20900-R1C)

Project Location: The project is located within the Bear Creek watershed, approximately 3 miles northwest of the town of Dinsmore, County of Humboldt, State of California; Section 29, T02N, R05E, Humboldt Base and Meridian, in the Showers Mountain U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 208-201-011-000; latitude 40.5264 N and longitude 123.6397 W at the point of diversion (POD).

Project Description: The project is limited to two encroachments. One (1) encroachment is for water diversion from an unnamed tributary to Mad River. Water is diverted for domestic use only. Work for the water diversion will include use and maintenance of the water diversion infrastructure. The one (1) other proposed encroachment is for installation of a pond overflow spillway. Work for this encroachment will include excavation, installation of new properly sized spillway, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
