Project Title: DuPont Stream Crossing Project (Lake or Streambed Alteration Agreement No. EPIMS-41368-R1C)

**Project Location:** The Project to be completed is located within the Fish Creek – South Fork Eel River watershed, approximately 4.1 miles southwest of the town of Benbow, County of Humboldt, State of California. The Project is located in Section 16, T05S, R03E, Humboldt Base and Meridian; in the Garberville U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 222-071-028-000; latitude 40.0223 N and longitude 123.8381 W at the stream crossing.

**Project Description:** The Project is limited to one encroachment. The single proposed encroachment is to upgrade an existing culvert. Work for this encroachment will include excavation, removal of the existing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring of the inlet and outlet, as well as the downstream channel for approximately 15 feet, as necessary to minimize future erosion.
