Project Location (include county): The project is located at an unnamed tributary to Weber Creek, in the County of El Dorado, State of California; Latitude 38.699491, Longitude -120.808277; Assessor's Parcel Number: 051-461-059-000.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number ELD-29860-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Sergei Oleshko.

The project is limited to the construction of a new access road and 12-inch storm drainpipe off Black Rice Road, and a basketball court with a retaining wall within the riparian habitat zone. Approximately four valley oak trees with a diameter at breast height (dbh) ranging from four to eight inches may be removed along the unnamed seasonal drainage on Black Rice Road. Approximately 2,817 square feet will be graded to construct a concrete basketball court and retaining wall. The new access road will be approximately 360 feet long and impact 867 square feet of riparian habitat.
