**Project Description:** The Yolo County Cache Creek Area Plan (CCAP) is a rivershed management plan adopted in 1996 that regulates off-channel mining and in-channel restoration along the Lower Cache Creek corridor. The CCAP Update is an integrated set of proposed modifications to the CCAP and the ordinances that implement it, to reflect changing conditions in the creek, analysis of monitoring data collected as a part of the program, new regulatory requirements, and clarifications and corrections.

**Notice:** This is to advise that on December 17, 2019, the Yolo County Board of Supervisors approved Resolution 19-175 to Certify the EIR; Resolution 19-176 to Amend the County's General Plan and Adopt the CCAP Update; an Ordinance to Amend Various CCAP Ordinances; and an Ordinance to Rezone 13 Properties. Pursuant to Section 21152 of the PRC and Section 15094 of the CEQA Guidelines, the following determinations have been made:

1. The project will have a significant effect on the environment.
2. An Environmental Impact Report was prepared and certified pursuant to the provisions of CEQA.
3. Mitigation measures were made conditions of approval of the project.
4. A Mitigation Monitoring Plan was adopted for the project.
5. A statement of overriding considerations was adopted for this project.
6. Findings were made pursuant to the provisions of CEQA.


