Project Title: Timbuctoo Utility Relocation Project (Streambed Alteration Agreement No. 1600-2018-0280-R2).

Project Location (include county): The project is located along a two-mile segment of State Route (SR) 20 at Big Ravine Creek, Sanford Creek, and an unnamed tributary, each within the Yuba River watershed, in the County of Yuba, State of California.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2018-0280-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, State of California Department of Transportation. The project is limited to relocation of PG&E electrical facilities. In support of the electric transmission relocation activities, PG&E will relocate and replace six approximately 50-foot electric transmission wood poles with six, up to 75-foot wood poles as well as one approximately 45-foot wood distribution slack pole. This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A statement of overriding considerations was not adopted by CDFW for this project.
