City of Los Angeles Sidewalk Repair Program will include:

- 1. New ordinance to revise the way sidewalk repairs undertaken pursuant to a legal settlement are reviewed and approved.
- 2. Street Tree Retention, Removal and **Replacement Policy:**

Street tree replacement to removal ratios:

- 2:1 in years 1-10
- 3:1 in years 11-21 2:1 in years 22-30





Environmental Review Process







Sidewalk Repair Program Details:

- ~ 42,719,225 square feet of sidewalk repair anticipated
- ~ 12,860 street trees removed over 30 years
- ~ 30,405 street trees planted over 30 years
- No net loss in street tree canopy
- The Draft EIR analyzes and discloses the potential environmental impacts as a result of the Sidewalk Repair Program:




