PROJECT DESCRIPTION: The State Water Resources Control Board (State Water Board) is a Responsible Agency for the Project. The State Water Board's Clean Water State Revolving Fund (SRF) Program is financing the Project. The Project includes an influent pump station at the WWTF with submersible sewage pumps placed in a wet well, the installation of a rotary drum screen, an extended aeration system with suspended aerators, rehabilitation of the existing wastewater discharge pipe, construction of a new pump station at the existing outfall pipe, and construction of a new 4-inch diameter force main pipe between the new pump station and the land application site.

PUBLIC AGENCY APPROVING PROJECT AND CARRYING OUT PROJECT: The State Water Board has approved SRF financing for the Project described above on April 15, 2021. The Loleta Community Services District (District) will be carrying out the Project. The State Water Board has made the following California Environmental Quality Act (CEQA) determinations regarding the Project:
