## Notice of Availability of Draft Environmental Impact Report/Environmental Assessment (EIR/EA) with Draft Individual Section 4(f) Evaluation

To Whom It May Concern,

In partnership with the Alameda County Transportation Commission, the California Department of Transportation (Caltrans), the lead agency under the California Environmental Quality Act (CEQA) and the National Environmental Policy Act (NEPA), is pleased announce that the Draft Environmental Impact Report/Environmental Assessment (Draft EIR/EA) with Draft Individual Section 4(f) Evaluation for the Oakland Alameda Access Project (formerly known as the I-880/Broadway-Jackson Interchange Improvements Project) in Alameda County, California has been completed and will be released for public review and comment.

The Oakland Alameda Access Project would improve multimodal safety and reduce conflicts between regional and local traffic; enhance bicycle and pedestrian accessibility and connectivity within the project study area; and improve vehicular mobility and accessibility between I-880, SR-260, the City of Oakland's downtown neighborhoods, and the City of Alameda. It would also reduce freeway-bound regional traffic and congestion on local roadways and in area neighborhoods. Project elements include modification of the connection from the Posey and Webster tubes to I-880, modification of the existing westbound I-980/Jackson Street off-ramp, removal of northbound I-880/Broadway off-ramp, bicycle and pedestrian and "complete streets" improvements.
