## NOTICE OF MARIN COUNTY BOARD OF SUPERVISORS HEARING Appeal of the Environmental Manager's Determination-Notice of Preparation (NOP) of Environmental Impact Report (EIR), North Coast Land Holdings LLC Planning Application on the former Golden Gate Baptist Seminary Site, 201 Seminary Drive, Mill Valley APN 043-261-25 and -26; 043-262-03 and -06; 043-401-05, -10 and -16; and 043-402-03 and -06 Project ID P1490

NOTICE IS HEREBY GIVEN that the Marin County Board of Supervisors will consider issuing a decision on the Appeal of the Environmental Manager's Determination that the North Coast Land Holdings LLC Planning Application requires the preparation of an Environmental Impact Report (EIR) pursuant to the California Environmental Quality Act (CEQA) and the County's Environmental Impact Review Guidelines, during a public hearing scheduled on Tuesday, November 10, 2020. The applicant for the appeal is Riley F. Hurd, III, on behalf of the Seminary Neighborhood Association. The property is located at 201 Seminary Drive, Mill Valley, (the former Golden Gate Baptist Seminary site) further identified as Assessor's Parcel 043-261-25 and -26; 043-262-03 and -06; 043-401-05, -10 and -16; and 043-402-03 and -06.

The project that is the subject of the appeal consists of the following: North Coast Land Holdings, LLC has submitted an application for development on the former Golden Gate Baptist Seminary property on the Strawberry Peninsula in Mill Valley. The proposed project includes a residential care facility for senior citizens and would replace a majority of the existing residential housing, as well as provide new residential housing. In addition, a pre-school and fitness center that would both be open to the public are proposed. Twenty percent of the proposed units would be reserved as below market rate housing. More than 75 percent of the 127-acre campus would be preserved as open space, athletic fields, paths and plazas. No change to the scope of the existing use permit for higher educational use is being proposed.

(Government Code Section 65009(b)(2).)
