The Project will result in impacts to 0.94 acres of California tiger salamander (Ambystoma californiense) habitat including temporary impacts to 0.37 acres; the Project will permanently remove 0.57 acres of California tiger salamander habitat. The Project is expected to result in incidental take of California tiger salamander, which is designated as a threatened species under the California Endangered Species Act.
