<u>Project Description</u>: The California Department of Toxic Substances Control (DTSC) adopted an Addendum to the previous Initial Study/Negative Declaration (IS/ND) and approved the Standardized Hazardous Waste Facility Permit to continue operating a Hazardous Waste Treatment and Storage Facility for non-RCRA hazardous waste, pursuant to authority granted under California Health and Safety Code Chapter 6.5 and California Code of Regulations, Title 22, Division 4.5, Chapter 20.

The Facility operates as a hazardous waste storage and transfer facility that accepts, transfers, accumulates, and stores non-RCRA used oil, antifreeze, oily water, and oily debris in the South Waste Storage and Transfer Area, located at the southern portion of the Facility property boundary. The Facility currently consists of four 10,000-gallon tanks, one 2,500-gallon tank, one 7,500-gallon tank, and a 440-gallon container storage area. The container storage area accumulates and stores oily debris in containers. Additional activities and modifications included in the Permit Renewal are:

- facility's name change to Advanced Environmental Inc. dba World Oil Environmental Services-Dixon,
- ownership change to Advanced Environmental Inc. dba World Oil Environmental Services-Dixon,
- a facility operator change to World Oil Environmental Services at Compton,
- truck-to-truck or container-to-container transfer activities for rejected loads,
- installation of a container rinsing unit with up to 240 empty containers per day capacity,
- used aqueous parts washing solution and empty containers as new waste streams, and
- construction of the North Waste Storage and Transfer Area (11,303 square feet).

The North Waste Storage and Transfer Area construction includes the addition of the Unit 4 a tank farm (Unit 4), Unit 6 loading/unloading area (Unit 6), and Unit 5A/B container storage and treatment area (Unit 5A/Unit 5B).

As Responsible Agency under the California Environmental Quality Act (CEQA), DTSC approved the above-described project on January 15, 2021, and has made the following determinations:

- 1. The project will not have a significant effect on the environment.
- A Negative Declaration was prepared for this project pursuant to the provisions of CEQA.
- 3. Mitigation measures were not made a condition of project approval by DTSC.
- 4. A Statement of Overriding Considerations was not adopted for this project by DTSC.
- 5. Findings were not made pursuant to the provisions of CEQA by DTSC.
