Chapter 4 FORM LETTERS

The Central Coast Regional Water Quality Water Board (CCWB) received a large number of form letters during the public review and comment period for the Draft Agricultural Order 4.0 (DAO 4.0) and the Draft Environmental Impact Report (DEIR). Form letters are letters which are identical or essentially the same other than the name of the person submitting the letter. The form letter received during the public review period generally urged the CCWB to adopt strong protections for water quality, including numeric limits and the maximum vegetated buffer requirements.

Rather than provide numerous repetitive responses to each individual letter, one response is provided to each substantive comment raised in the form letter in this chapter. Similar to Chapter 3, the individual comments within the form letter example are bracketed and assigned an alpha-numeric code. Responses are then provided in correspondence to the alpha-numeric coding.

I'm writing to urge you to approve strong protections for water quality as you move forward with the draft
Agricultural Order 4.0. As you know runoff from farm pesticides and fertilizers damages drinking water,
groundwater and wildlife habitat. This new order takes some important steps to rein in that pollution along the
Central Coast, but it must do more to protect the region's water quality.

Specifically I urge you to adopt strong numeric application and discharge limits for farm nutrients such as fertilizers.

And I urge you to adopt strong numeric discharge limits for pesticides, with comprehensive tests for aquatic toxicity.

FL1-3 I also urge you to adopt the maximum vegetated buffers between all waterways and farm fields. These setbacks are an effective, low-cost way to improve water quality while providing benefits for wildlife habitat.

While Agricultural Order 4.0 does take some important steps to better protect water quality — especially for drinking water and other human uses — it must be strengthened beyond the current draft. And it must better protect the needs of aquatic life and endangered species, as required by both state and federal law.

Finally the new order must reduce loopholes that loosen protections for wetlands and riparian habitat. And it must restore areas adjacent to man-made ditches that were once natural waterways and are crucial to safeguarding water quality.

FL1-6 Together these measures will put us on a path to meeting our goals and cutting pollution. Please take strong steps to ensure the Central Coast's water quality knowing you have my full support.

Chapter 5

REVISIONS TO THE DRAFT ENVIRONMENTAL IMPACT REPORT AND DRAFT AGRICULTURAL ORDER 4.0

This chapter describes revisions made to the Draft Environmental Impact Report (DEIR) and Draft Agricultural Order 4.0 (DAO 4.0). Most notably, as described in Chapter 1, *Introduction*, the DAO 4.0 was revised to remove the riparian and operational setback requirements, as reflected in the Revised Agricultural Order 4.0 (RAO 4.0). The DEIR was subsequently revised to reflect the RAO 4.0. No changes to the DEIR were determined to be necessary based on the changes from the RAO 4.0 to the Proposed Agricultural Order 4.0 (PAO 4.0). The DEIR was also revised based on certain specific comments, as identified in Chapter 3, *Individual Responses to Comments*, and at the initiation of CCWB staff and consultants.

All substantive revisions to the DEIR are shown in <u>underline</u>/strikeout in Volumes 1 (Main Body) and 2 (Appendices) of this Final Environmental Impact Report (FEIR). The revisions to the DAO 4.0 were provided to the public in "track changes" format during the RAO 4.0 review period, which lasted from January 26, 2021 to February 25, 2021. The PAO is included in Volume 2 of this FEIR as Appendix A.

5.1 Changes to the Draft Agricultural Order 4.0

5.1.1 Revised Agricultural Order 4.0

As described in Chapter 1, the DAO 4.0 was revised based on comments received during the DAO 4.0 review period and discussions with the CCWB Board. The RAO 4.0 included the following changes from the DAO 4.0:

- Addition of discount factor for organic fertilizers
- Addition of nitrogen scavenging credit for cover crops and high carbon amendments
- Addition of third-party alternative compliance pathway for groundwater protection
- Addition of third-party program priority areas and follow-up implementation and work plan due dates for surface water protection
- Streamlined total nitrogen applied (TNA) and irrigation and nutrient management plan (INMP) summary reporting section
- Streamlined surface water protection requirements section

- Removal of slope and certified sediment and erosion control plan requirements for impermeable surfaces, but with continued and modified requirements to manage stormwater discharge volume and intensity from impermeable surfaces
- Removal of some riparian area management requirements (i.e., riparian area management plan, and operational and riparian setbacks), but with continued and modified requirements to document and maintain existing riparian areas

5.1.2 Proposed Agricultural Order 4.0

Following the RAO 4.0 review period, based on comments received on RAO 4.0, additional changes were made to RAO 4.0 to create the PAO 4.0. As indicated above, from a California Environmental Quality Act (CEQA) standpoint, these changes were not substantive and did not affect the environmental analysis contained in Volumes 1 and 2 of the FEIR. The changes from RAO 4.0 to PAO 4.0 included the following:

- 1. Order Effectiveness Assessment and Evaluation
 - a. Revised heading from "Order Effectiveness Evaluation" to "Order Effectiveness Assessment and Evaluation"
 - b. Added Water Code section 13263 language to this paragraph
- 2. General Reporting
 - a. Removed irrigation system type from information required in the eNOI form
 - b. Added irrigation system type to information required in the TNA report
- 3. Third-Party Programs
 - a. Revised third-party program criteria related to physical presence to add flexibility
 - b. Removed instances of cooperative and replaced with third-party program
- 4. Organic Fertilizers
 - a. Clarified that liquid organic fertilizers are excluded from the organic fertilizer discount
 - b. Clarified that application of organic fertilizers is reported at the crop level and not the ranch level
- 5. Nitrogen Removal Conversion Coefficients

- a. Clarified that the CCWB will develop standard protocols for nitrogen removal conversion coefficients in coordination with UCCE and CDFA
- 6. High Carbon Amendments included as part of R_{SCAVENGE}
 - a. Added examples of high carbon amendments
- 7. Drinking Water Notifications to Domestic Well Users
 - a. Clarified timeline for drinking water notification to domestic well users
 - b. Added statement for status of drinking water notification to well users to the eNOI form
 - c. Removed statement for status of drinking water notification to well users from the ACF
- 8. Third-Party Alternative Compliance Pathway for Groundwater Protection
 - a. Clarified that ranch-level groundwater discharge monitoring will not be required for members
 - b. Removed groundwater trend monitoring from the draft and final workplan process
 - c. Added groundwater protection area assessment and effectiveness to the draft and final workplan process
 - d. Revised groundwater protection (GWP) targets to refer to them as "collective interim and final GWP targets."
 - e. Removed the word "cooperative" from Third-Party Alternative Compliance Pathway for Groundwater Protection title
- 9. Follow-Up Surface Receiving Water Implementation
 - a. Added objective to "Evaluate the condition of existing perennial, intermittent, and ephemeral streams and riparian and wetland areas, including degradation resulting from erosion or irrigated agricultural discharges of waste."
- 10. Definitions
 - a. Removed access road definition
 - b. Added MRP and MMRP definitions
- 11. Cost Considerations

- a. Copied table related to management practice cost information from the EIR and included it in the cost considerations section of Attachment A (Findings).
- 12. General Formatting and Spelling Errors

5.2 Changes to the Draft Environmental Impact Report

5.2.1 Changes to Align with the Changes to Draft Agricultural Order 4.0

The DEIR was revised to align with the changes to the DAO 4.0, as reflected in the RAO 4.0 (see Section 5.1.1). Most significantly, the Project Description (see Volume 1 of this FEIR, Chapter 2) was revised to remove the description of the riparian and operational setback requirements, since these were removed from the DAO 4.0. The "Riparian Area Management for Water Quality Protection" section of Table 2-3 was modified, and Project Objective 1.d. was revised to remove "and restoring."

The removal of the riparian and operational setback requirements was carried throughout the remainder of the DEIR, including Chapter 3, Environmental Analysis. Generally, mention of the setback requirements, including any analysis of the potential environmental impacts of implementing the riparian and operational setback requirements, was struck from the DEIR. In Section 3.1, Agriculture and Forestry Resources, this led to the significant and unavoidable impacts to Important Farmland and Williamson Act contract lands (Impacts AG-1 and AG-2) being reduced to less than significant (since the significant and unavoidable impact determination was entirely driven by the riparian and operational setback requirements). In Section 3.3, Biological Resources, discussion of the beneficial effects of the riparian and operational setback requirements (e.g., creation of new/restored riparian habitat, protection/restoration of water quality and aquatic beneficial uses) was struck from DEIR, although this did not change any of the significance determinations. In Section 3.8, Hazards and Hazardous Materials, references to the setback requirements were removed; however, the discussion of food safety concerns under Impact HAZ-8 was still applicable since riparian buffers could still be installed as a reasonably foreseeable management practice under the RAO 4.0/PAO 4.0 and this would have similar implications for food safety.

In Chapter 4, *Alternatives*, the revision to Project Objective 1.d described above (to remove "and restoring") was carried over to the discussion of the alternatives screening criteria in Section 4.3.2. Similarly, the discussion of "Would the alternative lessen or avoid one or more of the Proposed Project's significant environmental impacts?" in Section 4.3.2 was revised to reflect the elimination of the Proposed Project's significant and unavoidable impacts on agriculture resources due to the removal of the riparian and operational setback requirements in RAO 4.0. Although the Proposed Project would no longer result in significant and unavoidable impacts, it would still potentially impact the following resources/resource topics (these impacts could be reduced to less than significant with implementation of mitigation measures): biological resources, cultural resources, hazards and hazardous materials, hydrology and water quality, noise, and tribal cultural resources. The alternatives analysis in Section 4.4 was similarly revised to remove discussion of the Proposed Project's significant and unavoidable impacts on agricultural resources (e.g., during comparisons between the alternatives and the Proposed

Project) and/or the beneficial impacts of the Proposed Project on biological resources due to the riparian and operational setback requirements.

Because the Environmental Advocate Alternative would require a 30-foot minimum riparian buffer for all ranches with a waterbody on or adjacent to the ranch, this alternative would continue to have a significant and unavoidable impact on agricultural resources (since this requirement would result in conversion of Important Farmland to non-agricultural uses). By contrast, the Proposed Project, due to the changes incorporated in RAO 4.0, would no longer have a significant and unavoidable impact on agricultural resources (although it would now also be less effective in curbing nonpoint source pollutant discharges due to the lack of riparian and operational setback requirements). This fact was reflected in the discussion in Section 4.4.3, as well as in Section 4.5, which discusses the environmentally superior alternative. The Ag Organization Alternative would continue to potentially reduce many of the construction-related (short-term) effects (all less than significant or less than significant with mitigation) of the Proposed Project due to less management practice implementation, although it would potentially allow for removal of existing riparian vegetation in or near waterbodies not regulated by the Clean Water Act. Overall, with the changes to the Proposed Project, some of the scores for environmental costs and benefits between the respective alternatives in Table 4-4 changed; however, the Proposed Project remained the highest ranked, meaning that it best accomplishes the water quality goals of the CCWB, while minimizing environmental impacts to the extent possible.

In Chapter 5, *Other Statutory Considerations*, Section 5.2 was revised to state that no impacts were found to be significant and unavoidable for the Proposed Project. Mentions of the riparian and operational setback requirements were struck from the chapter and the discussion of cumulative impacts to agricultural resources was revised to reflect the changes to the riparian area management requirements incorporated in RAO 4.0. Given that the Proposed Project would no longer require or definitely result in conversion of Important Farmland to non-agricultural uses, the Proposed Project's contribution to Impact CUM-1 (Cumulative Impacts on Agricultural Resources) was revised to less than considerable (from considerable).

With respect to the other changes incorporated in RAO 4.0, the cross-references to the locations of specific requirements in the Order were updated throughout Table 2-3 in Chapter 2 to reflect the updated structure/section numbering in RAO 4.0. Additionally, Figure 2-2 was updated, and a new Figure 2-3 was added to describe the updated phasing and prioritization included in RAO 4.0 (no more riparian priority areas; groundwater phase areas and surface water priority areas now shown on separate figures). Further, description of the requirement for enrollees whose ranches have impermeable surfaces during winter on slopes greater than 5 percent to have Sediment & Erosion Management Plans designed by a qualified professional was removed from Chapter 2 (e.g., Table 2-4).

Apart from the removal of the riparian and operational setback requirements, the other changes from the DAO 4.0 in RAO 4.0 (see Section 5.1.1) did not greatly affect the environmental analysis in the remainder of the DEIR. Removal of the slope and certified sediment and erosion control plan requirements for impermeable surfaces would reduce the cost of compliance for growers and this cost was removed from Table 3.5-17 in Section 3.5, *Economics* (see Volume 1 of the

FEIR). Other changes (e.g., third-party options for groundwater and surface water, streamlined reporting and requirements sections, and addition of discount factor for organic fertilizers and nitrogen scavenging credit) would similarly, if anything, likely reduce the cost of compliance for growers. None of these changes would reasonably lead to increased management practice implementation or otherwise substantially increase potential for environmental impacts.

5.2.2 Changes in Response to Specific Comments on the Draft Environmental Impact Report

As indicated in Chapter 3 of this FEIR (Volume 3), the DEIR was revised based on specific comments received, where warranted. Although shown in Volumes 1 and 2 of this FEIR, these revisions are reproduced here for reference.

Response to Comment D-6

In response to Comment D-6, the text in Section 3.3, *Biological Resources*, has been updated to reflect that the Santa Clara Valley Habitat Plan is a natural community conservation plan (NCCP), as well as a habitat conservation plan (HCP). Specifically, the text on page 3.3-5 has been revised as follows:

The above list of HCPs was developed based on review of USFWS's database of HCPs. Apart from the Santa Clara Valley Habitat Plan, which is a HCP/Natural Community Conservation Plan (NCCP), nNo other natural community conservation plans (NCCPs) were identified within the central coast region based on review of online resources.

Additionally, the text on page 3.3-32 has been revised as follows:

As described in Section 3.3.2, there are a number of HCPs in effect in the central coast region, including the Santa Clara Valley Habitat Plan, which is a HCP/NCCP (no other known NCCPs were identified).

Finally, the text on page 3.3-33 has been revised as follows:

As such, these activities would not conflict with the adopted HCPs <u>or NCCP</u> in the central coast region.

Response to Comment D-12

In response to Comment D-12, the text in Appendix C was revised to reflect that the foothill yellow-legged frog's current listing status under the California Endangered Species Act (CESA) is "endangered" within the Proposed Project area. Specifically, the text on page C-15, in Table C-1, under the heading "Legal Status (Federal/State/CNPS or WBWG)" for Foothill yellow-legged frog, has been revised as follows:

Response to Comment D-13

In response to Comment D-13, the text in Appendix C was revised to reflect that tricolored blackbird's current listing status under CESA is "threatened". Specifically, the text on page C-22, in Table C-1, under the heading "Legal Status (Federal/State/CNPS or WBWG)" for tricolored blackbird, has been revised as follows:

In response to Comment BN-97, the text in Chapter 2, *Project Description*, in Table 2-3, on pages 2-14 through 2-17, the table heading has been revised as follows:

Response to Comment BN-112

In response to Comment BN-112, the text in Section 3.0, *Introduction to the Environmental Analysis*, was revised to clarify the baseline date used for the environmental analysis in Chapter 3 of the DEIR. Specifically, the text on page 3.0-2 has been revised as follows:

The baseline differs for each resource topic and is described in the "Environmental Setting" section within each topical resource section. While \$\pm\$The NOP was issued in February 2018, and in accordance with the CEQA Guidelines, the environmental analysis for the Proposed Project considered to have commenced in fall of 2017. Therefore, the baseline for this DFEIR analysis is the physical environmental conditions that existed in fall of 2017at the time the NOP was published.

Response to Comment FI-26

In response to Comment FI-26, the text in Table 2-9 has been revised to add "fallowing" as a reasonably foreseeable management practice. Specifically, the text on page 2-37, in Table 2-9, under all four table headings, has been revised as follows:

Fallowing

Response to Comment FI-27

In response to Comment FI-27, the text in Table 2-9 has been revised to add "practices for soil health" and associated examples as reasonably foreseeable management practices. Specifically, the text on page 2-37, in Table 2-9, under all four table headings, has been revised as follows:

Practices for soil health: soil armor, minimize soil disturbance, plant diversity, continued live plants/roots, livestock integration (USDA, NRCS)

5.2.3 Changes Initiated by Central Coast Water Board Staff and Consultants

The DEIR was revised at the discretion of CCWB and consultants to correct typos or errors and/or to update or correct certain language for the FEIR. The substantive changes are shown in in Volumes 1 and 2 of this FEIR and are described here. The changes to the DEIR initiated by CCWB and consultants included the following:

- In Chapter 2, Project Description (Section 2.2.1), the discussion of Agricultural Order 3.0 and the court-mandated expiration date of Agricultural Order 3.0 was revised to state that the court granted a 75-day extension, such that Agricultural Order 3.0 will now expire in April 2021.
- In several areas of the DEIR (e.g., Chapter 2, Section 2.2.2; Chapter 4, Section 4.4.1), it was clarified that the courts did not find Agricultural Order 2.0/3.0 to be deficient in their entirety, but rather found that certain aspects of the existing order requirements did not comply with the Nonpoint Source Policy.
- In Section 3.5, Economics, Table 3.5-17 was revised to correct several errors in the total cost estimates for Agricultural Order 3.0 vs. Agricultural Order 4.0 (reported estimated costs in the DEIR were higher than actual) and to generally align the cost estimates in this table with those in Attachment A of the RAO 4.0 (e.g., tracking and reporting costs for TNA and INMP reporting were separated out, consistent with the cost considerations section of Attachment A).
- In multiple areas of the DEIR, the text was clarified to indicate that Agricultural Order 4.0 would establish numeric targets and limits for discharges and fertilizer nitrogen applications, rather than just limits.
- The term "cooperative" was changed to "third-party" throughout the DEIR when referring to compliance pathways under Agricultural Order 4.0.

5.2.4 Changes to Create the Final Environmental Impact Report

As described previously, Volume 1 (Main Body) and 2 (Appendices) of this FEIR are the revised/updated versions of what had been the DEIR in its entirety. To create the FEIR, in addition to making the changes described in Sections 5.2.1 to 5.2.3, numerous other minor changes were made to update the DEIR text. For example, the title pages of the respective volumes were updated to say "Final Environmental Impact Report" and to reference the current date, and the tables of contents were updated to reflect the structure of the FEIR (i.e., three total volumes). Throughout Volumes 1 and 2, generally, "DEIR" was changed to "FEIR" in the text, and footers were updated with the current date and to say "Final Environmental Impact Report."

Additionally, the description of the public involvement process in the Executive Summary and Chapter 1, *Introduction* was updated to:

- Describe the DEIR and DAO 4.0 public review period in the past tense and describe the
 extension to the review period afforded to the public by CCWB due to the COVID-19
 pandemic;
- Describe the number and type of comment letters received during the DEIR and DAO 4.0 review period;
- Describe the RAO 4.0 public review and comment period and summarize the changes to the DAO 4.0 that were incorporated into the RAO 4.0;
- Summarize the comments received on RAO 4.0 during the review period and the changes to RAO 4.0 that were incorporated into the PAO 4.0 based on the comments received;
- Describe the process for preparing the FEIR, including responding to comments received during the DEIR and DAO 4.0 review period, as well as organizing the FEIR into three volumes (Volume 1 and 2 being the revised DEIR), and
- Remove the section of the DEIR describing how to submit comments on the DEIR.

Chapter 1, Section 1.6 also was amended to include a description of Volume 3 ("Comments and Responses to Comments on the Draft Environmental Impact Report and Draft Agricultural Order 4.0") and the chapters/contents of this volume. Generally, these changes were not considered substantive and are not shown in underline/strikeout in Volumes 1 and 2.
