Project Description (Proposed actions, location, and/or consequences).

The proposed project component addressed in the Second Addendum to the MND consists of the temporary installation and use of construction trailers at a site adjacent to the RWRF, including minor site grading, installation of the trailers, utility and communications lines connections, and chain link fencing. Following construction of the RWRF expansion, the trailers, utility and communications connections, and fencing would be removed. The MND being addended addressed EVMWD's proposal to expand its RWRF from an existing capacity of 8 million gallons per day (MGD) to 12 MGD. An NOD for the proposed project was filled with the State Clearinghouse on July 31, 2018. The first Addendum to the MND addressed additional construction staging and laydown areas; an NOD for that first Addendum was filled with the State Clearinghouse on April 5, 2022. EVMWD's RWRF is located at 31315 Chaney Street in the City of Lake Elsinore, approximately 0.5 mile northeast of Lake Elsinore. The proposed construction trailers site addressed in the Second Addendum to the MND is located between the RWRF and Strickland Avenue, encompassing Assessor's Parcel Numbers 375-291-007 through 375-291-015 (Coordinates 33.685472°N, 117.346197°W).

Identify the project's significant or potentially significant effects and briefly describe any proposed mitigation measures that would reduce or avoid that effect.

The Second Addendum to the MND incorporates the mitigation measures that were included in the MND and adopted when the proposed project was approved by Elsinore Valley Municipal Water District (Lead Agency). The mitigation measures applicable to the proposed installation and use of construction trailers adjacent to the proposed project site include pre-construction nesting bird/burrowing owl surveys, implementation of a cultural resources plan in case previously undetected archaeological resources are uncovered during ground disturbance, and implementation of a Tribal Cultural Resources plan in case previously undetected archaeological resources are uncovered during ground disturbance. As mitigated, the proposed project, including the use of the proposed construction trailers site addressed in the Second Addendum, will not have significant impacts on the environment.
