**Project Title:** Alpine County Culvert Rehabilitation and Replacement (Streambed Alteration Agreement No. 1600-2019-0124-R2).

**Project Location (include county):** Thirty projects are located along State Routes (SR) 4, 88, and 89 in Alpine County on Silver Creek, Monitor Creek, East fork, and West fork Carson River. The projects extend between post miles 19.48 and 31.11 on SR 4; 8.10 and 25.14 on SR 88; 6.84 and 18.33 on SR 89; located approximately 100 miles east of the City of Stockton.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has issued Amendment 1 to Streambed Alteration Agreement number 1600-2019-0124-R2, pursuant to section 1602 of the Fish and Game Code to the Permittee, California Department of Transportation.

The Caltrans right-of-way (ROW) has been reduced at project locations since the original design was permitted. Due to the reduced ROW, Caltrans may not be able to replace culverts at certain locations in their entirety. The amendment includes the installation of manholes to connect new replacement culvert sections with existing sections. The amendment also includes changes to the project description to remove or reduce the amount of rock slope protection (RSP) originally proposed for installation. As a result of the removed or reduced RSP placement proposed, the temporary and permanent impacts to stream and riparian habitats have been modified.

This is to advise that CDFW, acting as a Responsible Agency, approved the above-described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
