Project Title: Lake 29 Shoulder Widening and Truck Climbing Lane (Streambed Alteration Agreement No. 1600-2018-0374-R2).

Project Location (include county): The project is located along State Route (SR) 29 in Lake County from post miles 17.74 and 20.73 near the town of Lower Lake, State of California

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2018-0374-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, State of California Department of Transportation. The larger project is widening shoulders and constructing a 12-foot wide northbound truck climbing lane. The subject project is limited to replacement and extensions of eight existing culverts including flared end sections and installation of rock slope protection.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
