**Project Title:** Big Canyon Coastal Habitat Restoration and Adaptation Project – Phase 2A (Lake or Streambed Alteration Agreement No. 1600-2018-0235-R5)

**Project Location (include county):** The project is located within the Big Canyon Nature Park and includes a segment of the Big Canyon Creek, a tributary to Upper Newport Bay, in the County of Orange, State of California; Latitude 33.630890, Longitude -117.880724. The Project is located in the City of Newport Beach, east of Upper Newport Bay and west of Jamboree Road, on the U.S. Geological Survey (USGS) Newport Beach 7.5 minute series quadrangle topographic map.
