The 9,912 linear-foot Imjin Parkway alignment extends from Reservation Road to northwest of Imjin Road and also includes: (1) improvements to Imjin Road, Marina Heights Drive, Abrams Drive, Preston Drive, and Ready Court; (2) staging area near Imjin Road/8th Street intersection; and (3) traffic signal modification at Reservation Road/Imjin Road intersection. Project Description: This Project involves widening the roadway; intersection improvements; adding buffered bicycle lanes; incorporating bus pullouts for local bus service; installation of new pedestrian pathway and roadway lighting; traffic signal modification; and various drainage improvements. The Project will result in permanent impacts to 21 acres of Monterey gilia (Gilia tenuiflora ssp. arenaria) habitat.
