**Project Title:** Buck Avenue Bridge Replacement Project (Lake or Streambed Alteration Agreement No. 1600-2019-0307-R3)

**Project Location:** The Project is located at Alamo Creek on Buck Avenue in the City of Vacaville, County of Solano, State of California; Latitude 38° 21' 20.18" N, Longitude 122° 0' 27.26" W. The nearest address is 598 Buck Avenue, Vacaville, CA 95688, which is northeast of the Project.


**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2019-0307-R3, pursuant to section 1602 of the Fish and Game Code to the project Applicant, City of Vacaville.

The Project is limited to the removal of a vehicular bridge and two associated pedestrian bridges to be replaced with an approximately 54-foot long, 54-foot wide single-span, prestressed concrete slab bridge with a clear span. A temporary pedestrian bridge will be installed on the upstream side of the bridge during construction and removed upon completion. A total of six trees will be removed. In addition, three elderberry bushes will be removed. Temporary dewatering of Alamo Creek will occur during the Project if the creek is not completely dry.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on January 24, 2020 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the  mitigated negative declaration /  negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures  were /  were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan  was /  was not adopted by CDFW for this project.
5. A statement of overriding considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to California Code of Regulations section 15091.
