Project Title: Rice Crossing Road Bridge Replacement Project (Lake or Streambed Alteration Agreement No. 1600-2019-0015-R2)

Project Location: The existing bridge is located in unincorporated Yuba County, California on Rices Crossing Road over Oregon House Creek approximately 0.04 miles southeast of Marysville Road. Latitude: 39.35578 and Longitude: -121.2784.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2019-0015-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Steve Campbell at Yuba County Public Works.

The purpose of this project is to replace the existing structurally deficient bridge with a new and structurally sound concrete bridge in the same footprint as the existing bridge and provide bank stabilization of the surrounding area.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on 05/16/2019 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
