
Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2019-0582-R1, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Trout Unlimited.

Decommission 3.08 miles of riparian road along Moody Creek including eight potential fill failures, 15 stream crossings, and seven other features to include springs, swales, bank erosion, and road runoff/hillslope gully sites.

This is to advise that CDFW, acting as the Lead Agency, approved the above described project on 07/15/2019 and has made the following determinations regarding the project:

1. The project will not have a significant effect on the environment.
