Pursuant to your request, Earth Strata Geotechnical Services has reviewed the foundation plans prepared by Saddles for Storage Tank by CYTSA, dated March 28, 2014; Sheets 1 and 2 of 2 LPG Ventures by Flat Pier Assy, dated October 5, 2010; Structural Calculations for a 30,000-gallon LPG Tank by Ransome Manufacturing, undated; for the LP Gas Bulk Plant Facility and Preliminary Grading Plan by JMM Consultant, dated March 12, 2001. The purpose of our review was to evaluate the plans with regard to the geotechnical recommendations outlined in the referenced reports. Our review indicates that the geotechnical recommendations outlined in the referenced reports have been incorporated into the aforementioned plans.

The soil bearing pressure required is 700 pounds per square foot (psf) for stability of the propane tanks. The upper 2 feet of soil should be compacted to 90% of ASTM D 1557 which will enable the soil bearing pressure for the tank foundations to be in excess of 1,000 psf.

For RV Storage and Propane (LP Gas) Bulk Plant Facility Earth Strata Geotechnical Services will perform soil testing during construction where all tests will be in excess of 95% compaction based upon ASTM D 1557 at the subject site. We are recommending that the driveways will be suitable for use as a fire access road and can withstand a 75,000-pound fire truck in all weather conditions upon completion of construction.
