Project Location (include county): Two Pier retrofits and one large scale Rock Slope Protection (RSP) removal project are located along State Route (SR) 20 between Post Miles (PM) 17-17.1 in Sutter County, and between Post Miles 0.0-0.4 in Yuba County, on the Feather River.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2019-0201-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, California Department of Transportation.
