Dear Mr. Hawkins,

I live on and am part owner along with my brothers of the 160 acres on the Southwest corner of Florin and Eagles Nest Rds. My brothers and our extended family also own more farmland in the area. I have many concerns about the expansion of the mine.

Since my residence is very close, I have all the usual concerns: noise, long hours (until 10 pm on weekdays) and Saturday hours, and possible approval of different hours if the "public benefit outweighs the community hardship", dust, lights, and protection of ground water from possible contamination.

The addition of the asphalt and cement recycling facility is a concern. As I understand it it will be placed near the current processing facility not near neighboring homes. We have been assured that it will not cause any additional traffic etc. and will not contaminate the ground water and surrounding land area. It has been stated by mine reps that the recycling plant will not add additional truck traffic. I'm still unclear about how that works if they're trucking in tons of material in from offsite.

Also, in general, I realize they must mitigate for noise but it is definitely a big concern, especially since they'll be out there working until 10 pm and Saturdays.

I have also been assured that, as is already their practice, there will not be trucks allowed down Eagles Nest Rd. The entrance/exit will remain the same and the new recycling plant will be located close to the current plant.

I was hoping that since the neighbors will now be subjected to the mining operation in close proximity to our homes that at least the composting operation would vacate, but apparently that will remain in operation. So in addition to the gravel mining, the neighbors will still be subjected to the stench the compost facility produces. I would like clarification as to when that will be leaving. As I understand it they will not be part of the reclamation. We are to be left with grazing land on the site and not industrial. And not left with a compost operation. They must be required to keep the odor under control, but there are days when it is bad.

Thank you for the consideration of my concerns regarding the Carli expansion project.
