Project Title: Heacock Street Truck Terminal Facility

General Project Location (City and/or County): County of Riverside

Project Description:
Plot Plan (PP 17-07): authorizes the construction of a paved trucking facility with a 450-square foot single-story guard house on an approximate 13.56-acre site. The paving area would include approximately 260 parking spaces and encompass 9.34 acres. The guard house would be located on approximately 0.01 acre. The project would include landscaping encompassing approximately 1.43 acres. Open space (1.57 acres) and a retention basin (0.61 acre) are proposed south of the proposed parking area. South of the open space and retention basin is an existing retention basin that is not proposed to be modified, and it encompasses approximately 0.6 acres. The project also includes the installation of two 36-inch pipelines to connect to the existing two 36-inch pipelines that convey surface water into the onsite drainage channel. The two proposed 36-inch pipelines would convey storm water received offsite to the proposed open space. Finally, the project includes the installation of a 14-foot high screen wall along the eastern and southern property lines.



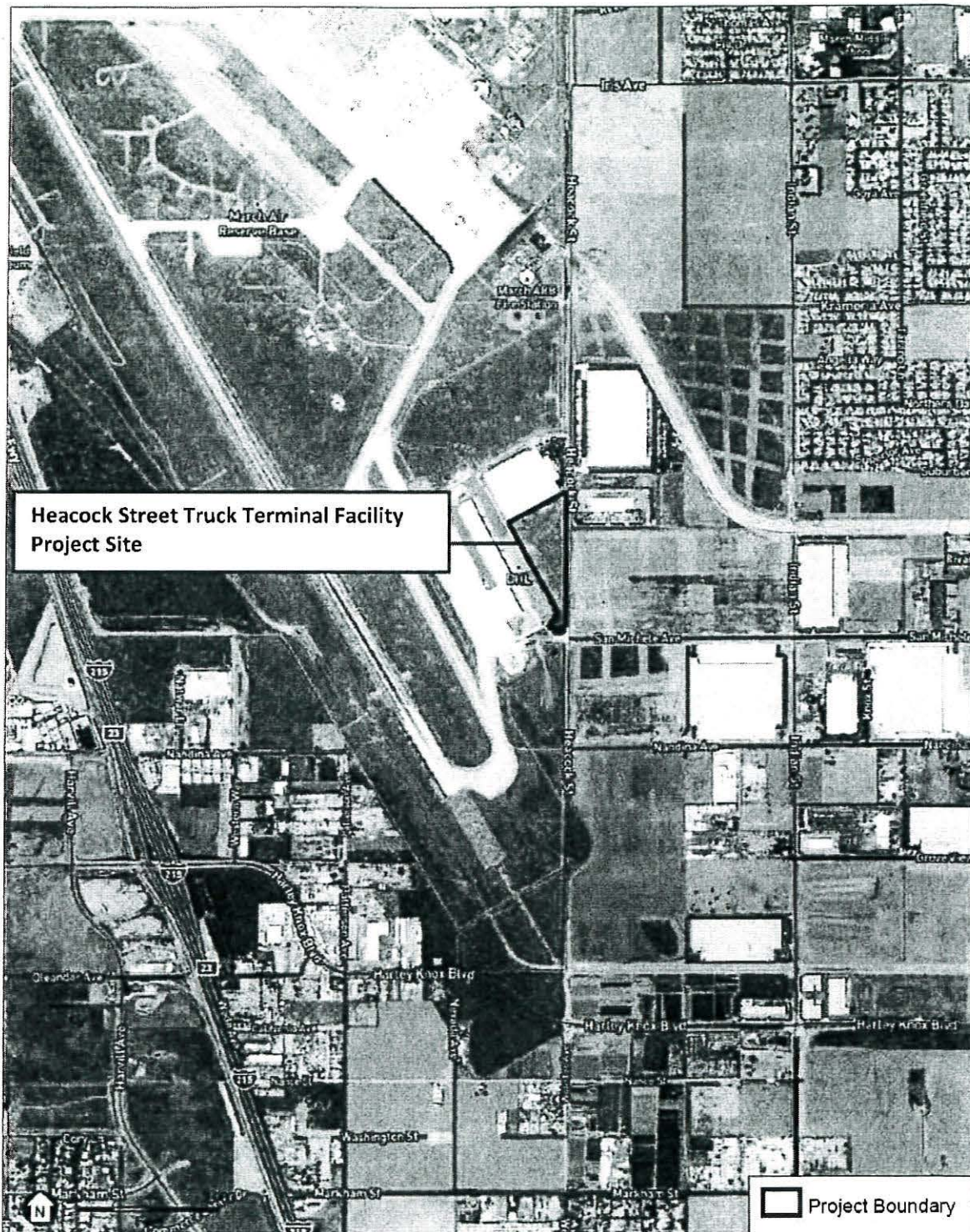
