Project Description: The proposed cultivation project described herein (Project) is the continuation of existing cultivation activities located in Trinity County on Assessor's Parcel Number (APN) 019-040-024. The applicant currently holds an Adult Use - Medium Mixed-Light Cannabis Cultivation License from the California Department of Cannabis Control (DCC) (CCL18-0000876 expires 2024-04-09) and is applying for a cannabis cultivation license from the Trinity County Planning Department (CCL-019) to cultivate up to 10,000 square feet (sf) of mature mixed-light canopy.
