The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-531) and currently holds a provisional Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL20-0001249, expires 2023-10-29). Proposed activities include the cultivation of approx. 9,856 sf of mature outdoor cannabis in four (4) 23'x80' (7,360 sqft) hoop houses and four (4) 8'x78' (2,496 sqft) full-sun canopy beds; one (1) 20'x100' (2,000 sqft) greenhouse is used for immature cannabis.
