Project Location (include county): The project is located at multiple unnamed tributaries to Secret Ravine, in the County of Placer, State of California. The approximately 7-acre project site is bounded on the north by Rocklin Road, on the east by Havenhurst Circle, and on the west by Monte Verde Park, and is approximately centered at latitude 38.787283, longitude -121.211300 (WGS 84 datum, decimal degrees).

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement EPIMS Notification Number PLA-36232-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, USA Properties Fund Inc.

The overall project is associated with mass grading to accommodate the construction of 180 multi-family residential units, site access, and recreational facilities on approximately 6 acres of developed area, with an additional 1 acre of open space. The project activities covered by this Agreement are limited to the construction of a culvert road crossing, construction of a water quality basin and associated outfalls, and mass grading/fill of aquatic habitat features.
