Project Description and Environmental Setting (Describe the project activities, project site and its surroundings, its location, and the environmental setting):

The California Department of Forestry and Fire Protection (CAL FIRE) is planning the creation of a 12 acre shaded fuel break along the northwest side of the Green Valley Highlands neighborhood in Solano County on land owned by the Vallejo Water District. The purpose of the fuel break will be to stop or slow a potential fire coming from the west of the neighborhood. It will be a place where crews could more effectively combat a fire and will improve the effectiveness of air tanker drops, thereby improving protection of the community in the event of a wildfire.

Vegetation in the project area is dominated by oaks (Quercus spp.), madrones (Arbutus menziesii), and bay laurel (Umbellularia californica). The understory is overgrown with shrub-like trees beneath mature specimens, constituting ladder fuels and contributing to a high fuel load. Project activities will target removal of shrubs and trees less than 6 inches diameter. resulting in a more open stand of healthier, well-spaced trees. The fuel break will be approximately 200 feet wide and approximately 2,600 feet long. Material will be removed by hand crews, and will be piled and burned for disposal.
