Location: Approximately 3,500 acres, more or less on eight parcels of State-owned indemnity and lieu lands within portions of Section 33, Township 28 North, range 17 East, MDM (parcel 1); portions of Section 9, Township 27 North, Range 17 East, MDM (parcel 2); portions of Section 15, Township 27 North, Range 17 East, MDM (parcel 3); all of Section 22, Township 27 North, Range 17 East, MDM (parcel 4); portions of Section 23, Township 27 North, Range 17 East, MDM (parcel 5); all of Section 26, Township 27 North, Range 17 East, MDM (parcel 5); all of Section 26, Township 27 North, Range 17 East, MDM (parcel 6); portions of Section 25, Township 27 North, Range 17 East, MDM (parcel 7); and all of Section 34, Township 27 North, Range 17 East, MDM (parcel 8), near Duck Lake, Lassen County.
