Description of Project: The project includes re-construction of a new control building, paving, perimeter block wall, and access gates; installation of water lines, sewer line, air lines, duct banks, and a new electrical substation; installation of two Metropolitan-furnished pumps, motors, and accessories; installation of five new surge tanks, access ladders, and platform; reconfiguration of the Service Connection B-5; and installation of new plug valves, flow metering controls, and a flow meter.

Accordingly, the proposed action qualifies under Class 1, Class 2, Class 3, and Class 4 Categorical Exemptions (Sections 15301, 15302, 15303, and 15304) of the State CEQA Guidelines.
