The California Department of Transportation (Caltrans) appreciates the opportunity to review the additional Access Location Exhibit Map provided by the proponent for the Hardin Flat LLC SDP18-002 project application (Camping Site) which depicts ingress/egress of the project site and the distance to the mainline. The proposed camping parcels have planned access off Hardin Flat Road (county road), which is 847 feet in distance that leads to the State Route (SR) 120.

Caltrans has previously reviewed the Tuolumne County Community Resources Agency (TCCRA) Site Development Permit SDP18-002 application (July 19, 2018) and provided comments on August 6, 2018 requesting additional mapping reflecting location of the driveway and displaying the locations with measurements (in feet) clearly showing distance to SR 120. Thank you for providing the additional mapping.


Caltrans has completed the review of the additional Access Location Exhibit Map and have the following comment:
