



Hi Joseph,

Last week we discussed the three projects listed below and stated that we would be applying the attached conditions of approval to all three projects. I would like to request the closing of consultation on all three projects if there are no other concerns at this time. The projects are

1. The Mill Creek Promenade consisting of the following 4 applications:

Specific Plan No. 2016-246 proposes establishment of a Specific Plan on a total of 58.5 acres for a planned residential and commercial development that includes a 194 townhouse community, 204 unit clustered single family residential subdivision, a 117,245 square foot commercial center comprised of retail, office, and restaurant space, a 33,171 square foot industrial and 1.7 acres of open space.

Plot Plan No. 2017-167 proposes to develop 58.5 gross acres into a planned residential and commercial development that includes a 194 townhouse community on approximately 15.6 gross acres, a 204 unit clustered single family residential development on 21.6 gross acres and a 117,245 square foot commercial center comprised of retail, office, and restaurant space on 16.8 gross acres, a 33,171 square foot industrial park on 2.8 gross acres and 1.7 acres of open space.

Tentative Tract Map No. 2017-165 (TR37324) proposes a subdivision of 21.6 gross acres into 204 single family residential lots. The subdivision is located on the east side of Sherman Road and south of Garbani Road.

Tentative Tract Map No. 2017-166 (TR37127) proposes a subdivision of 15.6 gross acres into one (1) airspace condominium map for 194 attached dwelling units. The subdivision is located on the southeast corner of Sherman Road and Garbani Road.

An EIR has been prepared and cultural reports have been sent for your review previously.

2. Harvest Glen consisting of the following 3 applications:

Plot Plan No. 2017-225 proposes the development of a 5.04 acre site with a new commercial center to include a gas station with a 4,967 sq. ft. convenience store and attached 1,102 sq. ft. quick serve restaurant, eight (8) fuel pumps under a 6,164 sq. ft. canopy, a 3,000 sq. ft. drive through car wash with outdoor vacuum stalls, and a 3,268 sq. ft. fast food restaurant with drive through. A large interim basin is also proposed which would partially develop the 5 acre site to the east. Ingress and egress is provided to the site from two (2) driveways off of Highway 74 and two (2) driveways off of Briggs Road. The project also partially develops a 20.35 acre property to the north with shopping center improvements and a driveway onto Briggs Road The project proposes 73 parking spaces.

Conditional Use Permit No. 2017-226 is specifically to allow for the car wash and convenience store with the sale of motor vehicle fuel. The project is located within the Menifee North Specific Plan (SP260) which refers back to the Scenic Highway Commercial (C-P-S) zone of Ordinance No. 348. This zone requires a Conditional Use Permit for the uses noted above.

Tentative Parcel Map No. 2017-227 proposes to subdivide 5.04 acres into 3 commercial parcels: Parcel 1 - 1.25 gross/0.98 ac net; Parcel 2 - 1.69 gross/1.30 net; and Parcel 3 - 2.10 gross/1.36 net.

An initial study is being prepared at this time and a hard copy of the cultural study provided at the meeting.

3. Menifee North Specific Plan Amendment consisting of a land use changes within the Specific Plan with no development proposed at this time. An EIR is being prepared and a hard copy of cultural study was provided at the meeting.
