A Director's Order (MC#19-046) has been issued to replace collapsed and deteriorated corrugated metal pipes (CMP) and repair eroded slopes in three locations on Interstate 8 in San Diego County. Location 1 (PM 10.75) will replace damaged CMP and reconstruct a failed slope and concrete ditch. Location 2 (PM 13.72) will reconstruct failed slope, headwall, and a basin. Location 3 (PM 14.09) will replace damaged CMP and reconstruct slope and inlet. All work is within Caltrans right-of-way. Environmental commitments listed in ECR must be met. Caltrans Environmental must be notified of changes to project scope.
