### RECIRCULATED NOTICE OF AVAILABILITY (NOA) / NOTICE OF INTENT (NOI) TO ADOPT A MITIGATED NEGATIVE DECLARATION (MND)

In accordance with the California Environmental Quality Act (CEQA) and the CEQA Guidelines, the Rosamond Community Services District (District) has prepared a Recirculated Draft Mitigated Negative Declaration (MND) that will identify and evaluate the environmental impacts of the Rosamond Community Services District Wastewater Treatment Plant Rehabilitation Project (Project).

**Project Title:** Rosamond Community Services District Wastewater Treatment Plant Rehabilitation Project

**Project Location:** The project site is located at 1460 10<sup>th</sup> Street West, Rosamond, California, approximately four miles northeast of the intersection of State Route 138 and State Route 14 near the southeastern boundary of Kern County.

**Project Description:** The expansion of the existing wastewater treatment plant from a treatment capacity of 0.5 million gallons per day (mgd) to 1.27 mgd by duplicating the existing Biolac/clarifier system, activated sludge system, secondary clarifier, and sludge drying beds. A new, larger Biolac/clarifier would be provided and the existing six sludge drying beds would be duplicated.

**Environmental Review and Public Comment:** The circulation of the Draft Mitigated Negative Declaration is to encourage written public comments.
