PROJECT DESCRIPTION / LOCATION: The project is located within the San Lorenzo watershed and the northern plan within the Deans Creek watershed approximately 1.0 miles southwest of the town of Ben Lomond, in the County of Santa Cruz, State of California; Sections 5 and 8, Township 10S, Range 2W, U.S. Geological Survey (USGS) Felton 1998, 2015, APN 072-022-01, 072-022-06, 072-081-06, and 078-331-02. The project is limited to map point crossings SX1, SX9, and SX10, which will have temporary Spittler Humboldt crossings installed, and SX2, SX2.5, and RX10 will have temporary pipes with logs and straw or soil placed over the pipe and crossing if water is present during harvest operations.

The California Department of Fish and Wildlife is executing Lake and Streambed Alteration Agreement Number 1600-2018-0134-R3 pursuant to Section 1602 of the Fish and Game Code to the project Applicant: Lawrence Holmes.

This is to advise that the California Department of Fish and Wildlife as a Responsible Agency approved the project described above on February 19, 2019 and has made the following determinations regarding the above described project pursuant to section 15096 (i).

1. The project will not have a significant effect on the environment.
