Notice is Hereby Given: The <u>City of Parlier</u> (City) is the Lead Agency on the below-described project and has prepared an Addendum to the previously adopted Mitigated Negative Declaration (State Clearinghouse #2019039162) for a TCP Removal Treatment System Project (Project). The complete Project description, location and the potential environmental effects are contained in the Addendum and previous Mitigated Negative Declaration (MND). The Addendum has concluded that no significant environmental impacts will occur as a result of the minor modifications to the Project as described below.

Project Title: Addendum to the Mitigated Negative Declaration for the City of Parlier 1, 2, 3 TCP Removal Treatment System

Project Location and Description: The project is located in the City of Parlier in four general areas: Location 1: This component extends from east of the intersection of South Whitner Avenue and Young Avenue south to Tuolumne Street, then west along Tuolumne Street, and south along South Milton Avenue, including adjacent to the Milton Lift Station, to the intersection with East Manning Avenue. Location 2: This component is on the south side of Industrial Drive, 0.1 miles west of South Mendocino Avenue. Location 3: This component is on the northeast corner of East Parlier Avenue and South Zediker Avenue. Location 4: This component is located on a small site located at the northwest corner of the John C. Martinez elementary school. The site is located on the east side of Foothill Avenue near the intersection at Forrest Street.

Addendum Description: The Addendum was prepared to address minor changes that were made to the project description after the MND was adopted by the City in May of 2019. The Addendum addresses installation and operation of an additional TCP treatment facility at Well #8 (Location 4) in the City as well as the addition of approximately 300 feet of pipeline that will be installed from South Milton Avenue to the proposed TCP treatment facility located north of Well #2A.

Document Availability and Public Review Timeline: Due to the time limits mandated by State law, your response to the Addendum must be sent at the earliest possible date *but not later than 15 days* after receipt of this notice.
