PROJECT DESCRIPTION The I-5 fuel break was designed to establish a 6-mile fuel break in grass and oak woodland habitat within the Caltrans right of way on the west and east sides of the Interstate 5 Highway between Red Bluff and the Hooker Creek/Auction Yard overpass. In 2014 the project area was expanded 4 miles north and now terminates at the Tehama/Shasta County line. The fuel break is sized appropriately for the fuel type. The fuel break is maintained annually and consists of utilizing CAL FIRE inmate crews to hand cut/scalp annual grass approximately 6-10 feet in width parallel to the interstate. The fuel break is reinstalled each year after the grasses have cured and cease to grow.
