<u>Project Activities</u>: The California Department of Toxic Substances Control (DTSC), pursuant to authority granted under California Code of Regulations, Title 22, Division 4.5, Chapter 20, Section 66270.61, has issued an Emergency Permit to Estate of Robert Willing (EPA ID: CAC003006147) to treat hazardous waste through a controlled reaction with a chemical solution. The hazardous waste to be treated consists of the following items:

The hazardous waste items are expired and currently being stored at Estate of Robert Willing located at 2104 Pacific Avenue in Anaheim, California. DTSC has determined as a safety precaution to prevent an accident or severe injury, an Emergency Permit should be issued to chemically stabilize the hazardous waste prior to transportation off site by Environmental Logistics. The treatment of the hazardous waste involves the addition of solution to the containers in a controlled manner to reduce the reactive or ignitable characteristics of the chemicals and will be carried out by Environmental Logistics chemists.

Treatment will take place within a designated exclusion zone. Only the Industrial Chemists from Environmental Logistics will be allowed in the exclusion zone. Donald Niren, a Hazardous Materials Specialist II with the Anahelm Fire and Rescue was contacted and made aware of the operation plan. Mr. Niren requested to be on site during the stabilization/treatment of the hazardous material.

Environmental Logistics will contact Mr. Niren and request his (or someone Mr. Niren can send in his place) presence for the stabilization/treatment. Mr. Niren's contact information is in the permit request. Movement, preparation, and treatment of the items will be in accordance with established standards.

Within 10 business days of the expiration of this permit, Estate of Robert Willing will submit a final report, signed in accordance with Title 22, California Code of Regulations section 66270.11(d). This report shall include certification that the treatment area has been cleared of all residual hazardous waste generated from this emergency treatment and all generated waste has been properly managed.

The Emergency Permit is effective beginning April 15, 2019 and shall expire on May 14, 2019.
