PROJECT LOCATION: 300 First Street, City of Woodland, Yolo County

PROJECT DESCRIPTION: The City constructed two triple-nested monitoring wells and two ASR wells at Well Sites 29 and 30. In addition, a 150 horsepower, diesel-powered generator was installed inside the existing well building at Well Site 30. The wells are drilled to depths of 500 feet. The ASR wells are municipal drinking water supply sources for the City, each capable of injecting treated drinking water for storage into the underlying aguifer and recovering the stored water at a target rate of 2,000 gallon per minute. The monitoring wells will allow long-term groundwater monitoring of aquifer conditions associated with the City's ASR program. Additionally, the City converted Well 28, an existing and permitted water supply well, into an ASR well.

PUBLIC AGENCY APPROVING PROJECT AND CARRYING OUT PROJECT: This is to advise that the State Water Resources Control Board (State Water Board) has issued a drinking water supply permit No. 01-09-19-PER-004 for the above described Project on April 18, 2019.
