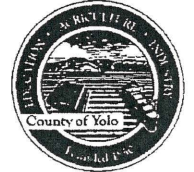

Project Location: The project is located in the unincorporated area of Yolo County, along County Road 78 in Brooks (APNs: 048-230-002 and 048-010-001)

### Project Description:

An Initial Study/Negative Declaration (IS/ND) was prepared for a proposed Fire Access Road to provide emergency vehicle access and wildfire protection to Tribal lands north of the project site. The project consists of an approximately 3,500 linear-foot gravel road that would run north from CR 78 across two agricultural parcels owned by the Yocha Dehe Wintun Nation (Tribe). The road would be 24 feet wide to accommodate emergency vehicles, and constructed with 18 inches of Class 2 aggregate base and subgrade, per recommendations detailed in the geotechnical engineering report completed for the project and grading permit.

This is to advise that the Yolo County Department of Community Services Director has adopted a Negative Declaration for the above-described project on May 15, 2019, and has made the following determinations:

1. The project will not cause a new significant effect on the environment or substantially increase the severity of a previously identified significant environmental effect.
2. A Negative Declaration was prepared for this project pursuant to the provisions of CEQA and adopted by the County.
3. Mitigation measures were not made a condition of the approval of the project.
4. A statement of Overriding Considerations was not adopted for this project.
