Description of Nature, Purpose and Beneficiaries of Project:

The California Department of Transportation (Caltrans) proposes a Highway Maintenance project to replace two (2) culverts along State Route (SR) 132 at post miles 45.55 and 46.40 in Stanislaus County, near the City of La Grange. The scope of work includes saw cutting and excavating the roadway to remove the culverts, installing the new culverts, and repaving the affected area of pavement. Culverts will be replaced by open trenching. All work will occur within existing Caltrans Right of Way (ROW). The purpose of this project is to replace the damaged and failing culverts. The project is needed to extend the service life of SR-132 and ensure motorist safety over these drainages.



General:

- o Environmental reevaluation will be required if the scope of the project changes to include additional areas or activities, or if previously unknown cultural or other sensitive resources are discovered. Contact the Environmental Office if project changes occur or sensitive resources discovered.
- o Contact the Environmental Office to attend the pre-construction meeting.

Cultural:

- o If cultural materials are discovered at the job site, do not disturb the resources and immediately:
 1. Stop all work within a 60foot radius of discovery
 2. Protect the discovery area
 3. Notify the Engineer
 4. The Department Investigates. Do not move cultural materials or take them from the job site. Retain a qualified archaeologist to assess the significance of the find. Do not resume work within the discovery area until authorized.
- o If human remains are discovered, State Health and Safety Code Section 7050.5 states that further disturbances and activities shall cease in any area or nearby area suspected to overlie remains, and the County coroner contacted. Pursuant to Public Resources Code Section 5097.98. If the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) who will then notify the Most Likely Descendent (MLD). At the same time the landowner will work with the MLD on the respectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.

Hazardous Waste:

- o Caltrans Standard Special Provision (SSP) 7-1.02K(6)(j)(iii) regarding a Lead Compliance Plan shall be included in the construction contract.

Biology:

- o If construction will occur during bird nesting season (February 15th through September 1st), contact the Environmental Office at least one month prior to the start of construction to schedule a pre-construction bird survey.
- o Caltrans Standard Special Provision (SSP) 14-6.03A regarding protective radii shall be included in the construction contract. If active migratory bird nests are observed, a 100-foot buffer shall be established. For hawks, a 300-foot buffer shall be established. For Swainson's hawk, a 600-foot buffer shall be established.
- o Contact the Environmental Office at least one month prior to the start of construction so a pre-construction botanical survey can be scheduled.

No permits required.
