A Director's Order was issued to replace a damaged light standard and foundation due to a vehicle collision on Route 20 in Sutter County at PM 16.44. The proposed scope of work is to remove the damaged foundation and install a new cast in drilled hole (CIDH) pile foundation. In addition, traffic control and COZEPP will be required. This project is needed to avoid the failure or threat of failure to the transportation system and to prevent or mitigate the loss or impairment of life, health, property, and essential public services. Failure to replace the foundation will result in no safety street lighting at the intersection.

All staging would take place within the Caltrans right-of-way. All work is within the Caltrans right-of-way. No borrow or disposal is required. No need for consultation or coordination. No permits are required.
