Project Title: Truckee River Legacy Trail Phase 4a (Lake or Streambed Alteration Agreement EPIMS Notification No. NEV-26149-R2)

Project Location: The Project is located in the Truckee River and its unnamed tributary drainages, in the County of Nevada between West River Street and Old Brockway Road in the Town of Truckee.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement EPIMS Notification Number NEV-26149-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Town of Truckee.

The project is limited to amending the Agreement NEV-26149-R2 to include the change in type of bridge from a modified stress ribbon bridge to a truss bridge. This will require a crane to set the truss, which will require the removal of approximately four (4) additional trees. The new truss bridge will reduce the number of footing locations from four (4) to two (2).
