Project Title: Interstate 10 Repaving Project (Post Mile 104.90 – 134.00) (California Endangered Species Act  
Incidental Take Permit No. 2081-2019-032-06(ITP))

Project Location (include county): The Interstate 10 (I-10) Repaving Project Post Mile (PM)104.90 – 134.00 (08-1C082) (Project) is located 9 miles west of the city of Blythe, in an unincorporated portion of Riverside County. The project is within the U.S. Geological Survey (USGS) 7.5-minute series Desert Center, Corn Spring, Sidewinder Well, Ford Dry Lake, East of Aztec Mines, and Hopkins Well, California, topographic quadrangles in Township 5S and 6S.

Project Description: This proposed project involves repaving the roadbeds, and upgrade guardrails, bridge rails, and drainage facilities. This project will construct two temporary detour lanes and crossover lanes in the existing median for traffic handling during construction. All existing bridges and/or drainage crossings, on the eastbound and westbound direction, will be widened towards the median. After the completion of construction, the median will be hydroseeded for erosion control and vegetation restoration. The Project will result in permanent impacts to 169.53 acres of Agassiz's desert tortoise (*Gopherus agassizii*) habitat. The Project is expected to result in incidental take of Agassiz's desert tortoise, which is designated as a threatened species under the California Endangered Species Act. The ITP referenced above as issued by CDFW authorizes incidental take of species listed under CESA that may occur as a result of Project implementation.
