If there are any changes to the proposed project's location or activities, an additional review by the Division of Environmental Planning will be required.

Hazardous Waste:

- The contractor is required to prepare a project specific Lead Compliance Plan (LCP) to prevent or minimize worker exposure to lead during traffic stripe and pavement marking removal and the disturbance of soil containing Aerially Deposited Lead.
- 2) The Non-Standard Special Provision (NSSP) 14-11.09 "Minimal Disturbance of Material Containing Regulated Concentrations of ADL" will be prepared for the PS&E package.
- 3) ADL impacted soil shall not be transported off site.

Cultural Resources:

1) If previously unidentified cultural materials are unearthed during construction, work shall be halted in that area until a qualified archaeologist can assess the significance of the find.

Biological Resources:

- All work will be limited to the prism of the roadway, or the edge of the unvegetated roadway for purposes of equipment maneuvering and traffic control.
- 2) There will be no clearing and grubbing of vegetation as a result of this project.
- 3) All appropriate Stormwater and Erosion Best Management Practices will be incorporated into the project specifications.
- 4) All pollution and litter laws and regulations will be followed by the contractor.
- 5) The Division of Environmental Planning will be provided the Project Specifications and Expenditures Review Package for review and comments.

Coastal Commission:

1) The Division of Environmental Planning will be provided the complete project plans and milestone dates prior to beginning the coastal exemption application process. The process is expected to take 3 months to complete.
