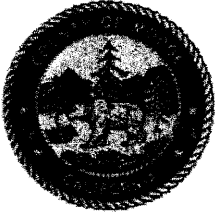

Description of Project: The Tulelake Airport is currently permitted by the State of California, Department of Transportation, Aeronautics Program to be operated by the County of Modoc and owned by the City of Tulelake. Title to the land was recently transferred from the City of Tulelake to Modoc Nation, formerly known as the Modoc Tribe of Oklahoma. The airport permit must be corrected to reflect the change in ownership.

Beneficiaries of the Project: Modoc Nation will be added to the permit as the owner of the airport.
