Notice of Intent to Adopt a Mitigated Negative Declaration

Do you want a public hearing on proposed rehabilitation of Interstate 10?



WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) is proposing to rehabilitate the existing asphalt concrete (AC) pavement on Interstate 10 (I-10) from Post Mile (PM) R134.0 to PM R156.5 in Riverside County, CA and the City of Blythe, CA. The project would address the current and future deficiencies of the existing pavement and improve safety and mobility of the traveling public. The project primarily consists of rehabilitation of the existing AC pavement. The scope also includes construction of two temporary detour lanes and crossover lanes in the existing median for traffic handling during construction; extension of existing culverts in the median; widening of bridges toward the median for the sole purpose of construction traffic handling; removal/replacement/repair of Rock Slope Protection (RSP) under existing and widened bridges; and hydroseeding the median for erosion control and vegetation restoration.

WHY THIS AD?

Caltrans has studied the effects that this project may have on the environment and found that the project would not significantly affect the quality of the environment. These findings are documented in a Draft Initial Study with Proposed Mitigated Negative Declaration/Environmental Assessment (Draft IS-MND/EA). This notice is to inform you of the preparation of the Draft IS-MND/EA and of its availability for you to read.
