Project Location: The project is located within the concrete lined portion of Colma Creek, a tributary to the San Francisco Bay, in the County of San Mateo, State of California; Latitude 37.6547, Longitude -122.4291 or Section 20, Township 3, Range 5, U.S. Geological Survey (USGS) map San Francisco South; Assessor's Parcel Numbers 014-041-160, 014-041-090, 014-041-170, and 014-041-120.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2019-0390-R3, pursuant to section 1602 of the Fish and Game Code to the project Applicant, the City of South San Francisco.

The proposed project will construct a water capture facility, within Orange Memorial Park, to improve water quality within Colma Creek. The water capture facility will divert water from Colma Creek into a series of underground cisterns and infiltration chambers to reduce water pollutants within Colma Creek. The proposed project will install a diversion channel within the Colma Creek concrete-lined channel, a storage reservoir, and an infiltration chamber.
