# NOTICE OF INTENT TRIBAL ENVIRONMENTAL IMPACT STATEMENT FOR THE PALM SPRINGS ARENA

July 10, 2019

The Agua Caliente Band of Cahuilla Indians (the "Tribe") is preparing an Environmental Impact Statement (EIS) for the proposed Palm Springs Arena (the "Project" or "Arena") in compliance with the Agua Caliente Tribal Environmental Policy Act (TEPA; Tribal Ordinance No. 28). The Tribe is acting as the lead agency for the preparation of this Tribal EIS (TEIS) because this Project is proposed within the boundaries of the Agua Caliente Indian Reservation.

### **Project Location**




## FIGURE 1 - REGIONAL LOCATION

The Arena is proposed on approximately 14 acres of Tribal land (the "Project Site") located in downtown Palm Springs. Figure 1 shows the regional location of the Project Site and Figure 2 shows the location of the site in downtown Palm Springs. As shown in Figure 2 the Project Site is bounded by East Alejo Road to the north, North Calle El Segundo to the east, East Amado Road to the south, and North Calle Encilia to the west.

### **Project Description**

The Agua Caliente Tribal Corporation, a federally chartered corporation and the Oak View Group, a Delaware LLC (the "Applicant") are proposing to jointly develop a multi-sport and entertainment arena, including a practice/training facility, locker rooms, other support facilities, and parking.

Total development would include approximately 252,000 net square feet consisting of a 173,000 square foot arena, 35,000 square feet of practice/training facilities, and 44,000 square feet of locker rooms/support facilities.

Currently, the lower two-thirds of the Project Site contains a surface parking lot. The upper one-third of the Project Site contains undeveloped land with one single-family home located adjacent to East Alejo Road. The proposed Project would include demolition of the existing parking lot and single-family home, and construction of the new Arena and associated facilities.

Uses surrounding the Project Site include single-family homes to the north, residential condominiums to the east, the Agua Caliente Casino Palm Springs and parking structure to the south, commercial uses, a surface parking lot, and a residential condominium complex to the west.

Probable Environmental Effects of the Proposed Project

Based on a preliminary review of the Project, the TEIS will study the potential for significant effects related

to the following environmental topics: aesthetics; air quality, including greenhouse gas emissions; cultural

resources; energy; water resources; land use; noise; public services; transportation/traffic; and utilities

and service systems.

Based on the existing characteristics of the Project Site and previous environmental review documents,

effects related to agricultural resources, biological resources, geology and soils, hazards and hazardous

materials, mineral resources, population and housing, recreation, and wildfire are not anticipated to be

significant and further analysis of these topics is not proposed in the TEIS.

**Submission of Comments** 

The Tribe invites your views, and/or the views of your agency, as to the scope and content of the

environmental information to be provided in the TEIS which is germane to your interests or to your

agency's statutory responsibilities in connection with the proposed Project. At a minimum, the Tribe

requests that you identify in your comments the environmental impacts that the Project may have and

reasonable mitigation measures that the Tribe should explore in the TEIS to address these impacts. In your

response, include your name, the name of your agency or organization (if applicable), and contact

information.

Responses to this notice should be sent at the earliest possible date, but not later than August 8, 2019.


